What you need to know!

As a still photographer, I understand that your family portraits should be unique. In addition to my studio, I offer on-location photo sessions so your portraits can be one of a kind, not department-store-generic.

I want your family to get the most out of your session, so please take a moment to read some answers to the most frequently asked questions.

How should we prepare for our session?

Think of the location(s) you're wanting to have as a backdrop to your portraits. Throughout the years I have photographed families at many fun locations such as Irvine Park, the Lake Calhoun Rose Garden, Playgrounds, a family's own home and backyard, and Summit Ave. I am open to your ideas, but have recommendations as well. When selecting your locations, please note that I do not have a portable dressing room. Usually families

wear a wardrobe that they can layer, so that changes are minimal. If photographing in my studio, there is a separate dressing area. Remember, we will be using ambient light (the sun) for many outdoor locations. If you are wanting more than one location, I ask that travel time between the two be at a minimal (no more than 20 minutes). With a two location session, travel time is included as part of the two hours.

What will our session be like?

Prior to your session, we will discuss locations and wardrobe. Please arrive to your session with your hair in your preferred style.

On location and in the studio, we will create images that range in expression and natural poses. I will photograph as many images as I can during your family session (expect an average of 40 - 60 images an hour for family sessions).

What should we wear?

Wardrobe is a tool used to compliment your portrait. My advice is to keep your wardrobe simple, and choose pieces that compliment each other. Often families wear colors that are similar (i.e. denim, kacki, navy, earth tones).

Other tips:

- I recommend clothing darker than your skin tone.
- Black is fine, but try to avoid white.
- Bring clothing that is solid in color.
- Avoid tops that have logos, stripes, and busy prints.
- Jewelry is fine, but should not be too distracting.

Please press your clothes before arriving to your session.
We want to avoid as many wrinkles as possible in your images.

Do we receive proofs and how long does that take?

Yes, all packages include an on-line web contact sheet and a CD of proofs (images on CD print up to 4x6 prints). The contact sheet is posted within 2-3 business days of your session. Having proofs online allows you to easily show family members your fun images. Your proofs will remain on my website for 60 days. Please make your order requests within that time. After 60 days I will remove your images from my site.

How do we order our professional prints?

When ordering prints, there are two options for families. You can schedule a 30 minute appointment with me where we can sit down together and I will take the order, or you can send your order to my e-mail account.

On the web contact sheet, you will notice that each proof picture has a number directly below it. Simply write the number of the proof and the size image you're wanting (i.e. Proof #4 - 8x10).

With appointments, please have the images you're wanting and the size prints written down. When ordering online, you can simply e-mail me your order information to my e-mail address: sarahmphoto@gmail.com

Please allow 7 - 10 business days for print orders. Prints can be picked up at my studio in St. Paul. If you'd like prints shipped to your home, there is an additional fee.

Please note, I do delete family files six months after the session date. If you are wanting a high resolution CD of your proofs it is available for purchase.

What are the payment options?:

- Cash
- Check
- Money order
- PayPal

Do you need a deposit prior to our session?

Yes, a deposit of \$100 is required to reserve your session date. Your deposit is due five business days before your session. I accept check, cash, money order, or pay pal for your deposit.

When do we pay the balance for the session?

The remaining balance is due at the time of the session.

Can we have an invoice or receipt?

Yes, invoices are available upon request.

What if we need to cancel our session?

You must cancel session 24 hours prior to the session date or you will forfeit your \$100 deposit.

Do you offer any discounts?
